Parent Loan for Undergraduate Student (PLUS) Application

Eligibility

To qualify for Federal PLUS Loan you must:

- ⇒ Not be in default on any type of federal loan.
- ⇒ Be a U.S. citizen or eligible non-citizen.
- ⇒ Apply for a Federal Student Aid Pin at www.pin.ed.gov.
- ⇒ Complete the 2010-11 Free Application for Federal Student Aid (FAFSA) at www.fafsa.gov.
- ⇒ Pass a credit check conducted by the loan servicing agency. A PLUS applicant who is determined to have an adverse credit history may receive the loan if he or she obtains a co-signer for the loan who passes the credit check.

Application Process

1. Submit a 2010-11 PLUS Loan Application to the MPC Student Financial Services Office.
2. Go to: StudentLoans.gov Click on “Request a PLUS Loan” and “Complete a MPN”. Following the instructions provided on the website.
