- ◇ **I am a ward or dependent of the court**, or I was a ward or dependent of the court until age 18.  
Attach a letter from your social worker confirming that you were a dependent of the court until age 18, or a letter stating that you are a participant in the Independent Living Skills Program (ILSP), or other court documentation showing that you were removed from your home because it posed a direct threat to your well being.
  
- ◇ **I was convicted of crime as a juvenile** and became a ward of the court through the California probation system as a result. You do not meet the definition of "ward of the court" for financial aid purposes because the State of California uses this term differently than other states (see FAFSA instruction at [www.fafsa.ed.gov](http://www.fafsa.ed.gov) for clarification). You will need to check your Student Aid Report (SAR) to be sure a parent signature and parental information in questions 59-93 is provided.
  
- ◇ **I am an emancipated minor/legal guardianship**. Attach a copy of the court's decision (from your state of legal resident) that you are an emancipated minor/legal guardianship.
  
- ◇ **I made an error on my FAFSA**. I am not an orphan/ward of the court or an emancipated minor. You will need to check your Student Aid Report (SAR) to be sure a parent signature and parental information in questions 61-95 are provided.
  
- ◇ **Unaccompanied homeless youth**. Attached is the documentation from a school districts homeless liaison, a director (or designee) of an emergency shelter program funded by the Department of Housing and Urban Development (HUD) or a director (or designee) of a runaway or homeless youth basic center or transitional living program.
